Product Review

Product: Press & Go Train Category: Toy Train Manufacturer: Fisher-Price

Scale: approximately G gauge (off-rail use only)

Powered: yes, batteries (included) Special features: sound, lighting effects Accessories included: five peek-a-blocks

Price: approximately \$20

Toot! Toot! Pressing the smokestack is all it takes for your littlest engineer to get this train moving, with lights, music, and lots of block bobbing, spinning, and teeter-tottering action. The Press & Go Train is part of Fisher-Price's extensive Peek-a-Block system.

When running, a block placed in the engine's cab bobs up and down. A turntable mechanism on the top of the tender engages special peek-a-blocks, causing movement inside the block, while two flashing LEDs light the block's

interior. The mechanism is well designed, and is not damaged if its movement is obstructed (such as by small fingers).

The detachable car has a flip-down back and a teeter-totter mechanism in the interior capable of loading two blocks. The teeter-totter action is activated by movement of the car, driven through one of the car's axles. A proprietary coupler is provided on one end of the car.

The rear axle of the tender is powered, and has traction tires for excellent performance on carpet as well as on hard surfaces.

Alex especially likes the various circusthemed tunes which play when the tender's turntable mechanism is pressed. While pressing the smokestack causes the train to move and play music, pressing the tender only plays music.

A holiday edition (in a red and green paint scheme, with appropriate holiday peek-ablocks and music) is seasonally available.

Gateway Division Meeting Minutes for October 18, 2004

Business Meeting

The meeting was called to order by Assistant Superintendent Richard Laux at 7:05 PM.

Visitors:

No new members or visitors were in attendance.

Minutes of the August Meeting:

The minutes of the September Meeting were distributed. A motion to approve the minutes was made by Bob Amsler and seconded by Dick Wegner. The motion was Approved by a voice vote of the membership.

Treasurer's Report:

A printed copy of the one month treasures report (September 20th through October 17, 2004) was distributed. The report indicated a balance in all funds of \$28,155,84. A motion to accept the report was made by Bob Amsler and seconded by Mike Satke. The motion was **Approved** by a voice vote of the membership.

Directors Report -- Board of Trustees:

Jim Anderson reported that the District Board of Trustees meeting would be held in January 2005. He also indicated that he attended the regional meeting on September 9, 2004. The purpose of the meeting was to look at the Mid-Continent Region Rules and Regulations. The goal is to complete the necessary revisions to bring the regional standards in line with the new national regulations by the

January Board of Trustees meeting. Bob Amsler is working on the revisions and hopes to have them completed by the middle of November. The Gateway Division will also need to complete the same process.

National Dues, Local Dues, RPO Cost, **Reminder Cards:**

Assistant Superintendent Laux initiated a rather lengthy discussion concerning the newly adopted national dues structure and the impact on local dues, mailings, printing costs, etc. Suggestions were made by Bob Amsler with regard to cost cutting measures, and he indicated that he would be rewriting the Division Bi-Laws which would deal with many of these problems. After considerable discussion, no action was taken pending Bi-Law revisions and further discussion by the officers.

Old Business:

The RPO

AP Awards - Don Taschner was not present and no formal report was made. Brian Post and other members reported that John Lee received his MMR at the National Convention.

Heart of America Fund – A question was raised by Dick Wegner concerning the disposition of the NMRA Heart of America Fund. Bob Amsler indicated that the National Treasurer is supposed to provide this information one month after the midyear and the annual board meetings. This information is given to the trustees and appears as a "separate account." To date these reports have not been made. A formal request for information should be made to the national treasurer with a copy to John Roberts.

Merchandise Sales - Hank Kraichelv reported that he sent an order including payment for the wheel sets we discussed. Tom Kues will be given the right of first purchase on the sets when they are received since he was missed at the end of the last sale. The wheel sets will be sent in the actual retail package of 12 sets each. He has an order form to be used by members interested in purchasing wheel sets. The form asks for you to indicated scale, wheel size, and number of packages desired. The price is the same as before, \$6.00 per package or \$.50 per wheel set.

RPO - No report.

Project Layout - Brian Post indicated that he was chairing the committee for the new layout. He brought a design plan proposal which included a wharf scene along a large body of water. The "water" has been purchased. The first work session will be held at John Schindler's house on Saturday, October 23, at 11:00 AM. John Kalin has donated 16 feet of retaining wall, and Chris Zigmont has provided a full size computerized track plan. Pete Smith has donated his house for some work sessions. Bachman has provided a command control system that comes with one decoder equipped GP 50. Donations of cars will be gratefully accepted. The foam will be joined together by 3M General Purpose 45 Spray Adhesive. Hank Kraichely asked about the provider of folding legs for the layout and Rich Laux provided information on a manufacturing company on Broadway at Highway 70.

Fall Meet - Hank Kraichely reported that the Quincy group would be bringing their layout. Brian Post reported that 25 vendors have purchased tables. Table prices have been raised from\$8.00 to \$12.00. Tom Bousman reported that all of the clinic spots are filled except for one. Information has appeared in the hobby magazines, and flyers have been distributed to all of the local dealers. Set up will be on Friday, November 5, at 3:00 PM. Volunteer help for the set-up is needed. A few dealers will be coming at that time. Three layouts are set for the tour and another layout is being sought in the west county or north county area. Randy Meyer, Dave Bartz, and Mike Peters have agreed to host.

New Business:

Volunteer Opportunities and Clinic Presentations - Richard Laux volunteered to take care of refreshments. Clinicians Richard Laux is trying to get Rail Cruise America to provide a presentation at the Holiday Party. Jim Ables will provide the December clinic. Jim Anderson provided more information about the Holidav Partv. He was interested in numbers, and requested that everyone bring a snack or appetizer of some sort. Bob Boedges indicated that he would send the reminder cards a week earlier than usual and include the food reminder in the "gray area" of the card.

Business Meeting

The meeting was called to order by Superintendent Thomas 8:00 PM.

Visitors:

No new members or visitors were in attendance.

Minutes of the August Meeting:

The minutes of the October Meeting were distributed. A motion to approve the minutes was made by Brian Post and seconded by Bill Levin. The motion was Approved by a voice vote of the membership. (John Schindler voted NO but as usual everyone ignored him. The membership realized that he was out on a one night pass, and no one wanted to make him feel bad and risk an uncontrolled outburst.)

Treasurer's Report:

Printed copies of three months treasures reports (September 20th through December 19, 2004) were distributed. The reports indicated a balance in all funds of \$27,069.79. A motion to accept the reports was made by Richard Lake and seconded by Brian Post. The motion was Approved by a voice vote of the membership.

Directors Report -- Board of Trustees:

Jim Anderson reported that the MOCOR Board of Directors meeting would be held on the last Saturday in January 2005. He also indicated that the Board of Trustees

meeting of the NMRA would be held on the second Saturday in January. He indicated he would be giving a more complete report at the next Division meeting. A great deal of time is being devoted to the issues surrounding the change to a single dues structure on the first of September. Superintendent Thomas pointed out that the regional meeting would also include consideration of the new constitution and bilaws. Anderson indicated that Bob Amsler is working on these revisions and they would be discussed at the Division level after the 1st of the year. They are Intermountain wheel sets in 33" and 36" sizes. They are being sold for \$6.00 per package and each package contains 12 wheel sets. To date he has sold 66 packages. The sets seem to be fine quality. He also has sets in N scale. The HO 36" sets may be sold out. Gary Hoover cars are still available.

RPO – The fall issue of the RPO and the updated membership directory should be going to the printer and into the mail by mid-December. The Winter issue will be published in mid-January.

Website Renewal – Superintendent Thomas announced that we renewed our contract with the hosting service to continue the Division website for the next 24 months.

World's Greatest Hobby Show -

Superintendent Thomas announced that the World's Greatest Hobby Show will be presented at America's Center on the weekend of January 8th and 9th. 2005. This is a project developed by the model railroad manufactures to promote the hobby to new modelers. There will be four shows nationally with the first show in New Jersey, followed by shows in St. Louis, Los Angeles, and Denver. The New Jersey show attracted 15,000 people, and would have had more if more parking had been available. The Jersey show was also limited by the high cost of advertising. It is anticipated that the St. Louis show will be even better attended. The shows are very popular with families and children. We will be present to welcome people into the hobby, and sell chances on the project layout. Hank Kraichely is coordinating the list of workers. Members that work will be admitted to the show free of charge. Members will have to pay for parking, or ride Metrolink. Our booth will be placed at the front of the hall near the main entrance. Times are 9:00 AM to 8:00 PM on Saturday, and 9:00 AM to 5:00 PM on Sunday.

Project Layout – Thanks were expressed to Brad Joseph and his crew for their work on the 2004 layout. The layout was displayed five times during the course of the year at GATS shows, our Regional Convention, and the Museum of Transport. The lavout cost \$553.85 to build and produced revenue in the amount of \$1,946.00 for a profit of \$1,392.15. This is near the amount of our Division operating budget for the year. The layout was won by a gentleman from Maryville on the final weekend of the season. GATS was paying us \$100.00 each time we displayed the layout. This has been changed to \$50.00 and the clinic presentations we were presenting are no longer being requested.

A brief slide presentation on the status of the 2005 layout was presented by Mike Satke and Bob Boedges. They announced the need for trees, rolling stock, figures, and vehicles.

Fall Meet – Hank Kraichely reported that the fall meet was very successful. The final paid attendance number was 206. We had 39 dealer tables and they all were pleased with the show. Several of the vendors have already indicated that they would be returning next year. Dave Lyon prepared a financial report which indicated a net profit of \$556.46. The membership thanked Hank and his workers for their support of the project.

New Business:

The need for clinicians, World's Greatest Hobby workers, and workers for the project layout have been covered under old business.

- Missouri HO Gaugers in Maplelwood will have there layout open for the last time is January 7, 2005. After that the layout will be dismantled.
- The O Scale National Convention will be held in St. Louis in June.

- The St. Charles Model Railroad Club will have their annual Flea Market on the 22nd of January, 2005.
- There is a very nice G Scale Layout on display during the Holidays at the Botanical Garden.

Display Boards – Where are the Division display boards?

Future Events – Brian Post indicated that we are scheduled to display the project layout at the GATS shows in February at Collinsville, and June in Belleville. We are

also signed up for the Dupo show in February but this has not been confirmed. The schedule also includes the Boeing show. We will contact the St. Charles club to see if we might display at their show in January. A request was made to publish all upcoming dates on our website.

Gateway Division Meeting Minutes for January 17, 2005

The meeting was called to order by Superintendent Mike Thomas at 7:06 PM. Superintendent Thomas introduced Brian Post who presented his clinic on the MRC Sound Decoder. The membership thanks Brian for his presentation.

Business Meeting

The meeting was called to order by Superintendent Thomas at 8:02 PM.

Visitors:

Bob and Dianna Sharp were introduced as new members. Jeff McKay was introduced as a visitor.

Minutes of the December Meeting:

The minutes of the December Meeting were distributed. The heading "Minutes of the August Meeting" was corrected to read "Minutes of the October Meeting." The last

sentence of the item "Division Merger" was corrected to read "A formal proposal will be made by Pete to the Regional Organization." John Schindler asked that the item concerning his "one night pass" be changed to a "two night pass." A motion to approve the minutes as corrected was made by Richard Lake and seconded by Jim Anderson. The motion was Approved by a voice vote of the membership.

Treasurer's Report:

Printed copies of the one month treasures report (December 20, 2004 through January 16, 2005) and the year end report for 2004 were distributed. The reports indicated a balance in all funds of \$27,248.82. A motion to accept the reports was made by Richard Lake and seconded by Dick Wegner. The motion was **Approved** by a voice vote of the membership. Hank Kraichely indicated he still had wheel sets available. The 36" HO sets and the "N" scale sets are sold out.

Directors Report -- Board of Trustees:

Jim Anderson reported that he and Bob Amsler had just returned from the mid-year NMRA Board of Trustees meeting which was held in Phoenix. He indicated that several motions had been passed during the session, but he would prefer to delay his report until he received the finished documents from the NMRA secretary. On September 1, 2005 the NMRA would be moving to the single dues structure. Dues paid for membership in the national association would include automatic membership in both the region and the local division. Subscriptions and other services would result in some "incremental dues." Any members that would elect not to pay the additional amounts would still be members and would have voting rights.

This was the last meeting of the Board of Trustees as it is currently configured. The July meeting will include only nine members instead of the seventeen members under the old system. The United States is being divided into

three districts; the Western District, the Central District, and the Eastern District. Each district will have one director on the board. There are three international districts including Australia, Canada, and Europe and each of those districts will have one director on the board. There will be two "at large" directors in the U.S. and one director approved by the presidents of all 17 regions. Jim will be running for the Western District Director position, as Missouri has been assigned to that District. Illinois has been assigned to the Eastern District. The divisions were organized based on membership not geography, resulting in the large area which makes up the Western District. Ballots will be in the February issue of Scale Rails.

A change in the dues structure was approved at the meeting. Affiliate membership without *Scale Rails* will be changed from \$23.00 to \$33.00. A full membership which includes *Scale Rails* will remain at \$45.00. These changes will go into effect on September 1, 2005. The "life membership" program will be discontinued, but those who have a life membership will continue to receive their benefits.

The length of the term of office for new board members was "staggered" by la lottery system. The Eastern Division Director's term will be for three years, the Western for two years, and the Central for one year. The same system was applied to the international representatives and the "at large" positions. This was done to avoid the problem of having a completely new board every three years. The changes do not effect regional or divisional make-up.

Division Merger:

Superintendent Thomas announced that the Mid-Continent Division meeting would be held in two weeks and that the merger of Division 20 from Southern Illinois with the Gateway Division 10 would be on the agenda. The merger was requested due to the fact that Division 20 only serves 8 to 10 members. The question which needs to be

answered concerns the number of representatives will be allowed for the expanded area. Will we still have one representative or two for the enlarged Gateway Division? Jim Anderson indicated that the merger would be approved and further that two positions would be allowed. This would necessitate a search to find someone willing to represent the Illinois members.

National, Regional, and Division News:

- Anderson also indicated that the Mid-Continent Region officers would be up for re-election on September 1, 2005. The Region is looking for volunteers to run for Treasurer. Ken Thompson has been filling this position for at least four years, and has decided to "take a break." The Regional position is not a difficult one, and Jim is looking for Candidates.
- Hank Kraichely encouraged all division members to take the time to vote for Jim Anderson in the national election.
- The Regional Convention will be held in Topeka, Kansas on June 3rd through 6th.

Gateway Division Changes:

Superintendent Thomas indicated that the Gateway Division will need to modify its constitution and bi-laws to reflect the new unified dues system to reflect the fact that any NMRA member is also a Division member with attendance and voting privileges. A supplemental fee would be required for the RPO since the Division would not be able to absorb the cost of printing and mailing the publication to over 300 members without additional funds. Bob Amsler indicated that he felt that an officers meeting should be held to determine the changes that need to be made, and the results of the meeting should be brought to the membership for a vote. Jim Anderson suggested that Divisional changes should be made after the Regional Meeting so that any additional factors could be taken into consideration.

Old Business:

AP Awards – Don Taschner was not present to present a report.

Merchandise – Wheel sets were discussed earlier in the meeting. Jack Templeton is still making and selling Division name tags. Gary Hoover cars are still available.

RPO – No report was available, and no set publication date was announced. Some concern was expressed concerning the delay in publication. Some discussion of computer programs was initiated with input from Venita Lake. Some further discussion involved the status of the membership lists.

World's Greatest Hobby Show -

Superintendent Thomas announced that the World's Greatest Hobby Show took place the weekend of January 7th through the 9th. 2004. The project layout was on display and chances were sold. Several new memberships were sold, as well as \$565.00 in raffle ticket receipts. These were best single weekend receipts in at least three vears. Superintendent Thomas thanked everyone who helped out over the weekend, and Brian Post offered special thanks to Bob Boedges and Mike Satke for taking the layout down to the show and taking it home. The vendors reported that sales were good especially in the area of children's toys, and train sets.

Project Layout –Three shows opportunities for the project layout were announced The St. Charles Show on January 22nd. In addition the Dupo show will be held on February 12th and the GATS show in Collinsville on February 19th and 20th. Brian Post indicated that he did have the Dupo and GATS shows on the schedule. Bob Boedges and Mike Satke agreed to take the layout to the St. Charles show. Volunteers to work all of the shows were solicited.

New Business:

Volunteer Opportunities: The need for clinicians, and workers for the various

shows with the project layout are still needed.

Club Layouts – No announcements or information.

John Schindler won \$20.00 in the drawing.

Adjournment - A motion to adjourn was made by Who Knows and seconded by Hank Kraichely. The motion was Approved by voice vote of the membership.
